#### **OVERVIEW**

Comm Unity Plus Services Limited (commUnity+) is looking to appoint up to three new Directors to the Board of Directors to contribute to our strategy and vision.

There are currently eight Directors serving on the Board of commUnity+. There may be a maximum of 11 Directors.

The Board meets six-eight times per year. Directors may also join a Committee of the Board.

All roles are voluntary, however reasonable costs to support Board participation will be met by the organisation. The organisation is committed to supporting Directors by contributing to governance training and professional development as a Director.

commUnity+ is a longstanding provider of community services based in the Greater Western and Northern Metropolitan areas of Melbourne. We strive to create positive change, growth, and enablement through a range of prevention and early intervention programs targeted to support people and communities experiencing disadvantage. We embrace the diversity of our people, such as diversity in disability, race, cultural background, ethnicity, age, gender identity, sexual orientation, or intersex status. Reasonable costs to support committee participation will be met by the organisation. We are committed to removing any barriers to applying or joining the committee.

As we are a company limited by guarantee, our Directors must meet all statutory obligations of company directors. The Board delegates management responsibilities to the Chief Executive Officer in accordance with the limits and guidance of the organisation's policies, the Board and Committees of the Board.

commUnity+ is a child safe organisation. Prior to commencing, prospective Directors will need to undergo a national Criminal Records Check and hold a current Working with Children Check. These Checks will need to be maintained.
